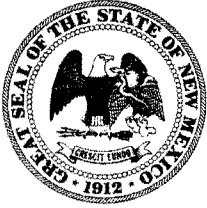

Dear Messrs. Rael and Graham:

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and the Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Work Plan for the Technical Area 21 Monitoring Well Network Reconfiguration* (Plan) dated July 18, 2011 and referenced by EP2011-0014.

NMED hereby approves the Plan with the following modifications.

1. At well R-7, configure the pump riser and the well head to facilitate potential future sampling of the lower intermediate zone screen with a portable pump.
2. At well R-8, retain both regional screens and reconfigure the well as a two-screen well with a dual-pump sampling system.



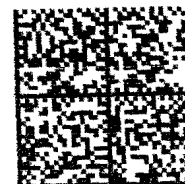
