
The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and the Los Alamos National Security L.L.C.'s (LANS) (collectively, the Permittees) *Request for Extension of Date for Submittal of Material Disposal Area B Investigation/Remediation Report* (Request), dated September 1, 2011 and referenced by EP2011-0302. The Permittees assert that a zone of elevated radioactive contamination was encountered in the Enclosure 1 excavation area, which has significantly reduced excavation rates based on DOE's total radiological material at risk requirements. The Permittees are unable to achieve the anticipated completion date for waste removal due to the reduced pace of excavation. NMED finds this to be good cause for the requested extension.
