
The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and the Los Alamos National Security, LLC (LANS) (collectively, the Permittees) *Updated Enclosures for Buildings or Fixed Structures Scheduled to be Demolished 2nd Quarter Calendar Year 2012*, dated May 10, 2012 and referenced by ENV-RCRA-12-0088/LAUR 12-20498. The Permittees submitted *Buildings or Fixed Structures Scheduled to be Demolished 2nd Quarter Calendar Year 2012* on March 28, 2012. This updated document was submitted in response to NMED notifying the Permittees during April 12, 2012 conference call that Enclosure 1, Demolition Reporting 2nd Quarter Calendar Year 2012, was incomplete. NMED has also received and reviewed the Permittees' submittal *Expedited Demolition Notification for 2nd Quarter CY 2012 Structures*, dated May 10, 2012.

As stated previously, the investigations are not complete at several Solid Waste Management Units (SWMUs) and Areas of Concern (AOCs) located within 50 ft. of the buildings proposed for demolition. Several of these SWMUs and AOCs are either scheduled or may be proposed for further investigation. The Permittees must ensure that the sampling locations and depths proposed in the approved work plans are not affected by these activities. The demolition activities must be documented so that any adverse impacts to the SWMUs/AOCs where investigations are not complete can be identified and evaluated.

The Permittees must provide a copy of the demolition reports, if prepared, to NMED within 30 days after the reports are completed in accordance with Section 1.17.3 of the Permit. Please contact Neelam Dhawan of my staff at (505) 476-6042 should you have any questions.
