Subject: Request to Withdraw Two Notification of Class 1 Permit Modifications for Attachment B, Part A Application, of the Los Alamos National Laboratory Hazardous Waste Facility Permit, EPA ID # NM0890010515

The purpose of this letter is to request the withdrawal of two notifications of Class 1 Permit Modifications submitted to the New Mexico Environment Department – Hazardous Waste Bureau (NMED-HWB). The modifications revised the Los Alamos National Laboratory (LANL) Hazardous Waste Facility Permit (Permit) issued to the U.S. Department of Energy (DOE) and Los Alamos National Security, LLC (LANS), collectively the Permittees, in November 2010. The two notifications were for permit modifications to Permit Attachment B, *Part A Application*, and were submitted to NMED-HWB on June 14, 2013 and August 26, 2013.


