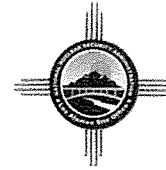

The attached 2013 Storm Water Individual Permit Annual Report is being submitted in accordance with the requirements of the National Pollutant Discharge Elimination System Permit No. NM0030759 (the Permit) for Los Alamos National Laboratory, issued to Los Alamos National Security, LLC, and the U.S. Department of Energy (the Permittees), effective November 1, 2010.

The 2013 Annual Report presents activities and milestones accomplished by the Permittees from January 1 to December 31, 2013. The Annual Report addresses the requirements in Section H.2 of the Permit, including the following:

- Summary of site-specific compliance status
- Monitoring results available during the reporting period
- Identification of pollutants of concern which exceed applicable target action levels
- Description of control measures installed
- Description of Corrective Actions required per Part I.E to be taken or having been taken, including completion date or targeted completion date, and progress update
- Highlights of any change of compliance status
- Lists of requests, for EPA's approval, including requests for change of monitoring location or Site deletion and any requests to place Site(s) into Section E.3 Alternative Compliance
- Summary of inspections performed


