Enclosed please find two hard copies with electronic files of the Sandia Wetland Performance Report, Baseline Conditions 2012-2014. Los Alamos National Laboratory (the Laboratory) has prepared this report in response to requirements set forth in the document "Work Plan and Final Design for Stabilization of the Sandia Canyon Wetland." The requirement for design of a Sandia wetland monitoring program was previously set forth in New Mexico Environment Department's (NMED's) "Approval with Modification, Interim Measures Work Plan for Stabilization of the Sandia Canyon Wetland" in response to the Laboratory's "Interim Measures Work Plan for Stabilization of the Sandia Canyon Wetland."

In the work plan, the Laboratory proposed reporting of Sandia wetland monitoring data to NMED by April 30 of each year. In its April 4, 2014, letter (EP2014-0121), the Laboratory requested a 60-day extension to submit the report because of delays in field work caused by September floods and early November snow fall. With submission of this report, the Laboratory has met the deliverable date of June 30, 2014.
