Dear Theodore Wyka, and Steven Coleman:

On February 28, 2024, the New Mexico Environment Department (NMED) received the United States Department of Energy (DOE), Triad National Security (Triad), LLC, and Newport News Nuclear BWXT-Los Alamos, LLC (N3B) (collectively referred to as the Permittees) *Class 1 Permit Modification Request for the Technical Area 54-38 West Outdoor Pad*, (Request) referenced by ESHID-603874/LA-UR-25-20673.

NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations 20.4.2.201.B(2) NMAC. The fee invoice is attached to this letter. If you disagree with the fee assessed, you may notify NMED in writing, at the address below, of the intent to appeal the invoice under the provisions of 20.4.2.302.A NMAC.

The New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.F NMAC requires the assessment of fees. Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Vanessa Baros, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
