The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) Technical Area 63 Transuranic Waste Facility Soil Vapor Monitoring System Report, Calendar Year 2025, Quarter 1 (Report) dated March 2025 and received on March 26, 2025. If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to the Finance Manager, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
