Dear Theodore Wyka and Steven Coleman:

On February 28, 2025, the New Mexico Environment Department (NMED) received the United States Department of Energy (DOE) National Nuclear Security Administration, Los Alamos Field Office (NA-LA) and Triad National Security, LLC (Triad) (collectively referred to as the Permittees) *Class 1 Permit Modification Request for the Technical Area 54-38 West Outdoor Pad*, (Request) referenced by ESHID-603874/LA-UR-25-20673.

The Permittees have provided this Request in accordance with the Code of Federal Regulations (CFR), Title 40, 270.42(a)(12), and Permit Section 3.1(3) for a Class 1 permit modification requiring prior approval. NMED has reviewed the Request and determined that it conforms with 40 CFR 270.42, Appendix I Item A.8 to remove permit conditions that are no longer applicable and that it is administratively complete. NMED has reviewed the Request and has updated the Los Alamos National Laboratory Hazardous Waste Facility Permit (Permit) to incorporate the approved changes described in the Request. NMED has modified the unit description for Technical Area 54-38 West Outdoor Pad in Permit Attachment A.
