The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) *2025 Technical Area 63 Transuranic Waste Facility Soil Vapor Monitoring System Report, Calendar Year 2025, Quarter 4 (Report)*, dated and received on December 18, 2025, and referenced by EPC-DO-25-374 and LA-UR-25-31963.

NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2), NMAC. The New Mexico Hazardous Waste Permit and Corrective Action Fee regulations, 20.4.2.201.F NMAC require assessment of fees. Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Vanessa Baros, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
