The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and Triad National Security, LLC (Triad) (collectively, the Permittees) *Closure Certification Report for Temporary Waste Treatment, Storage, and Repackaging Unit to the Los Alamos National Laboratory Hazardous Waste Facility Permit* (Certification Report), EPA ID #NM0890010515 (Closure Certification Report) dated and received on February 13, 2026, and as referenced by EPC-DO-26-021/LA-UR-26-20611.

NMED has determined that the closure Certification Report is administratively complete and accepted it for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations 20.4.2.201.B(2) NMAC. Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Vanessa Baros, NMED Hazardous Waste Bureau,
