Dear Mr. Schleman:

This letter serves as a notification as required by Condition B110.B(2) and B110.B(3) of NSR Permit 2195B-M3R4.

- Condition B110.B(2) requires Los Alamos National Laboratory (LANL) to notify the Air Quality Bureau in writing with the equipment serial numbers and the actual date of initial startup of each source within 15 days after the startup date.
- Condition B110.B(3) requires LANL to notify the Air Quality Bureau in writing the date when each new or modified emission source reaches the maximum production rate at which it will operate within fifteen (15) days after that date.

The two auxiliary boilers (Units TA-3-22-4 and TA-3-22-5) located at the TA-3 Power Plant started up and reached the maximum production rate on June 30, 2025. The serial number for TA-3-22-4 is 14974-1 and for TA-3-22-5 is 14974-2.
