The Request also contains an attachment illustrating the Permittees' responses to NMED's *Approval with Modifications, Work Plan to Conduct Reliability Assessment of*



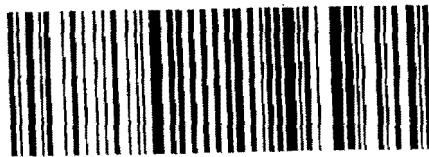

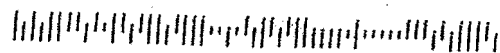
