On July 21, 2011, Los Alamos National Laboratory (the Laboratory) is scheduled to begin execution of investigation and remediation activities at the Cañon de Valle Aggregate Area at Technical Area 14. The scope of the sampling contained in this field campaign is documented in the Investigation Work Plan for Cañon de Valle Aggregate Area at Technical Area 14, dated September 2006.

Sampling and remediation activities are expected to last for 55 days, from July to September 2011. The Laboratory will notify New Mexico Environment Department Hazardous Waste Bureau staff of any changes to the schedule. The sampling results will be presented in the investigation report due to NMED on January 15, 2012.
