Dear Messrs. Rael and Graham:

The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and the Los Alamos National Security, LLC (LANS) (collectively, the Permittees) *Buildings or Fixed Structures Scheduled to be Demolished During Fiscal Year 2012*, dated September 13, 2011 and referenced by ENV-RCRA-11-0188/LAUR 11-05065. NMED provides following comments.

1. The building and structures numbers listed in the first and the last column for each row in Table (*Demolition Reporting Fiscal Year 2012*) are similar on pages 1 to 3, but different on pages 4 to 7. It is not clear why the building or fixed structure numbers listed in the first and the last column would be different. For example, the first row on page 4 includes discussion on structure 18-0037, and the last column of the first row states that structure 18-0147 was identified but not demolished in previous fiscal year. Clarify the

relationship of structure 18-0147 with structure 18-0037 and for all structures listed in these two columns on pages 4 to 7 in a replacement table

2. Structure 63-0001 was included in the table entitled *Attachment for FY 2012 Demolition Notification- Building hazardous Material Descriptions* but no description for this structure was provided in the table entitled *Demolition Reporting Fiscal Year 2012*.
Revise the table to include information related to the structure 63-0001.

The investigations are not complete at several Solid Waste Management Units (SWMUs) located within 50 ft. of the buildings proposed for demolition. Several of these SWMUs are or may be proposed for further investigation. Some of the proposed sampling locations are adjacent to the buildings scheduled for demolition. The demolition activities must be documented to ensure that there are no adverse impacts to SWMUs where investigations are not complete.

Pursuant to Section 1.17.3 of the Los Alamos National Laboratory Hazardous Waste Permit (Permit), NMED hereby requires notice of demolition 30 days prior to the commencement of demolition activities, for the following structures:



- 18-0030, Concrete Sheer Walls

- 18-0127, Steel Frame w/Concrete Sheer Walls
- 18-0187, Premanufactured Metal Tower
- 18-0188, Premanufactured Metal Tower
- 18-0189, Cast Concrete
- 18-0190, Reinforced Masonry Structure
- 18-0270, Steel Moment Frame
- 22-0001, Metal and Wood Framed Structure
- 35-0224, Trailer-Wood Lt. Frame
- 35-0226, Trailer-Wood Lt. Frame
- 35-0227, Trailer-Wood Lt. Frame

NMED notes that a notice for demolition of some of the structures listed above was sent on October 6, 2011. The Permittees must provide a copy of the demolition reports, if prepared, to NMED within 30 days after the reports are completed in accordance with Section 1.17.3 of the Permit. The response to the comments included in this letter is due no later than November 30, 2011.
