**SUBJECT: EXPEDITED DEMOLITION NOTIFICATION FOR STRUCTURES AT
TECHNICAL AREA 54**

The National Nuclear Security Administration (NNSA) and Los Alamos National Security, LLC (LANS) (collectively the Permittees) are informing the New Mexico Environment Department Hazardous Waste Bureau (NMED-HWB) of the need to expedite the demolition of structures summarized in the enclosure. These structures have recently been identified to receive funding and be demolished. Structure TA-54-0296 will be demolished prior to December 30, 2012. The remaining structures covered by this notification will be demolished within the January 1, 2013 through March 31, 2013 quarter.

Enclosure 1 satisfies the reporting requirements as outlined in Section 1.17 of the LANL Hazardous Facility Waste Permit (Permit). Demolition of buildings that appear on this list will not occur until 30 days after NMED has received this notification.

The Permittees understand that the investigations may not be complete at the Solid Waste Management Unit (SWMU) and Areas of Concern (AOC) located within 50 feet of the TA-54-0296 building proposed for demolition, and further investigation may be scheduled. The Permittees will ensure that the sampling locations and depths proposed in the approved work plans will not be affected by these activities. If inadvertent impacts occur on the SWMU where the investigation is not complete, demolition activities will be documented so that the impact on the SWMU can be identified and evaluated.

In addition, if a demolition report is prepared, a copy will be provided to NMED within 30 days after the report is completed, in accordance with Permit Section 1.1 7.3.




