NMED / LANL Technical Summary

April 6, 2015

LANL Technical Update:

- **Location of Nitrate Salt-Bearing Wastes**
 - Remediated nitrate salt-bearing waste containers.
 - All containers remain in the 375 Permacon.
 - Unremediated nitrate salt-bearing waste containers.
 - All containers remain in the 231 Permacon.
 - Newly suspect nitrate salt-bearing waste containers.
 - Containers are located in the 375 Permacon.
- **Monitoring - Daily Temperature**
 - Temperatures remain below 90°F.
 - Previous 3 days' temperature data attached.
- **Monitoring – Visual Inspections**
 - No abnormal conditions were observed.
- **Monitoring – headspace gas (HSG)**
 - Containers (SWBs) 68685 and SB50522.
 - Continue daily head space gas (HSG) sample collection.
 - April 4-6, 2015 HSG data attached.
 - H₂, CO, CO₂ and N₂O
 - Other containers:
 - A minimum of once per month HSG sampling will be conducted.
 - To date in April, LANL has conducted HSG sampling on 15 containers.
- **Additional measures currently underway**
 - As a conservative measure, LANL is currently conducting additional monitoring. This additional monitoring includes:
 - Containers (SWB) 68685 and SB50522.
 - LANL continuing *solid phase micro-extraction*.
 - Hourly temperature measurements are currently being performed on SWB 68685 and SB50522.
 - Five other SWB overpacks (containing 55-gallon drums of remediated nitrate salt-bearing waste).
 - Continue twice-weekly HSG sample collection.
 - April 6, 2015 HSG data attached.
 - H₂, CO, CO₂ and N₂O
- **Anticipated Changes to Nitrate Salt-Bearing Waste Containers (e.g. movement, re-packaging)**

- Currently, no further movements or re-packaging are occurring.
