The New Mexico Environment Department (NMED) has received a permit modification notification from United States Department of Energy and Los Alamos National Security, LLC, (collectively the Permittees). Entitled *Notification of Class 1 Modification to the Los Alamos National Laboratory (LANL) Hazardous Waste Permit Inspection Plan* dated July 7, 2015, referenced by WM-DO-15-0131 and LA-UR-15-23536.

The Permittees notified NMED of the updates made in Permit Attachments E of the Hazardous Waste Facility Permit (Permit) for Los Alamos National Laboratory (LANL). The NMED has reviewed the notification and hereby deems it administratively complete.

The New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2)(b) NMAC require the assessment of fees. The fee invoice for the Class 1 without Prior Approval Permit Modification was sent to the Permittees on August 14, 2015. Payment is normally due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. However, because NMED submitted an assessment of supplemental permit fees to the Permittees for State fiscal year 2016, and the Permittees transmitted payment of these fees, the fee invoice was paid under these supplemental fees.
