Dear Theodore Wyka and Jeannette Hyatt:

On August 17, 2023, The New Mexico Environment Department (NMED) approved the United States Department of Energy (DOE) and the Triad National Security, LLC. (Triad) (collectively the Permittees) *Class 1 Permit Modification Request to Amend the Closure Plan Schedule for Technical Area 16-399 Open Burn Unit, Revision 2.1* (Extension Request) dated and received August 7, 2023, referenced by EPC-DO-23-260/LA-UR-23-28963.

In the Approval letter, NMED stated: "The revised certification report is **due to NMED on or before November 17, 2023.**" However, on August 24, 2023, the Permittees approached NMED and clarified that the extension request was intended to only cover field activities since analytical results typically take 60-90 days to be sent to LANL.

To accommodate the analytical schedule, NMED is modifying the approval in accordance with the revised closure schedule, The **Closure Activities must be completed on or before November 17, 2023.** The final closure certification report is due to NMED within 60 days of the receipt of confirmatory sampling results from the analytical laboratory.

The Permittees must notify NMED in writing by an electronic mail, when closure activities have been completed. In addition, NMED must be notified when the Permittees have received confirmatory sampling analytical laboratory results.

As part of the summary accompanying the report, the Permittees must also include: a table of revisions, a summary documenting corrective action activities at the unit, including photos and a redline strikeout of the revised certification report (in both the electronic and hardcopy).
