The Department of Energy (DOE) and the Los Alamos National Security (LANS), LLC submitted a Class 1 permit modification request on April 3, 2012 to change the Los Alamos National Laboratory (LANL) Hazardous Waste Facility Permit issued to the Department of Energy and Los Alamos National Security, LLC (DOE/LANS).

After review, the New Mexico Environment Department Hazardous Waste Bureau (NMED-HWB) did not approve one requested modification requiring prior approval and two others that did not require approval. The 93 approved modifications were put into effect as requested by the Permittees under the conditions specified in 20.4.1.900 NMAC (incorporating 40 CFR §270.42(a)(1)). NMED incorporated these Class 1 modifications into the LANL Permit on June 5, 2012.
