LOS ALAMOS NATIONAL LABORATORY HAZARDOUS WASTE FACILITY PERMIT

The Department of Energy (DOE) and the Los Alamos National Security, LLC (LANS), collectively the Permittees, are required to provide public notice on two recent actions to the Los Alamos National Laboratory (LANL) Hazardous Waste Facility Permit issued in November 2010.

The first action is the approval of a Class 1 permit modification request dated September 4, 2012 to add a structure to the permitted unit at Technical Area (TA) 55 Outdoor Storage Pad. The New Mexico Environment Department Hazardous Waste Bureau (NMED-HWB) approved the request on October 31, 2012.

The second action is the Class 1 permit modification notification submitted on November 5, 2012. The modification includes an address change and corrections to non-substantive typographical errors. This permit modification includes administrative changes to the permit, and does not require NMED-HWB approval. However, the official text changes to the Permit must be made by the NMED-HWB.

These modifications have been prepared in accordance with Code of Federal Regulations, Title 40 (40 CFR) §270.42(a).
