This letter serves as a notification, as required by Condition B110.B(1) of NSR Permit 2195B-M3R1, which requires Los Alamos National Laboratory (LANL) to notify the Air Quality Bureau in writing no less than thirty days prior to the actual date of initial start-up of sources. This notification replaces the previous notification letter submitted on September 21, 2022, as the date of start-up was delayed again.

Two auxiliary boilers located at the TA-3 Power Plant of LANL, identified in NSR Permit 2195B-M3R1 as Units TA-3-22-4 and TA-3-22-5, are anticipated to start up between December 1, 2022- January 31, 2023.
